INSTRUCTIONS / FEES

CITY OF PACIFIC LICENSE APPLICATION PEDDLERS, SOLICITORS, CANVASSERS

False statements may result in a denial or withdrawal of license and are punishable by law.

Requirements:

1. A photograph of the applicant, taken within sixty (60) days immediately prior to the date of filing the application, which picture shall be two (2) inches by two (2) inches showing the head and shoulders of the applicant in a clean and distinguishing manner.
2. A Background check must be submitted with application. These can be obtained at www.machs.mshp.dps.mo.gov
3. At the time of making application for permit, a Surety Bond to the City in the amount of One Thousand Dollars (\$1,000) with surety conditional that the applicant shall comply fully with all the applicable provisions of the Code and Ordinances of the City and State laws regulating and concerning the business of peddling and guaranteeing to any citizen of the City that all money paid as down payment will be accounted for and applied according to the Representatives of the peddler, and further guaranteeing to any citizen of the City doing business with such peddler that the property purchased will be delivered according to the representatives of such peddler. Action on such bond may be brought in the name of the City to the use or benefit of the aggrieved person.

You must submit application, after approval you will be issued a License for the time you specify.

SECTION 630.060 HOURS OF OPERATION

It shall be unlawful for any peddler to engage in the business of peddling within the City between the hours of one-half (1/2) hour before sunset and 9:00 A.M. the following morning, or at any time on Sundays, except by specific appointment with an invitation from the prospective customer.

SECTION 630.130 FEE

Before any permit shall be issued under the provision of this Article, the applicant therefor shall pay a fee, based upon the duration of time he desires to engage in business in the City, as follows:

Per Day	\$ 5.00
Per Week	\$ 10.00
Per Month	\$ 30.00
Per Three (3) Months	\$ 50.00
Per Six (6) Months	\$ 75.00
Per Twelve (12) Months	\$100.00
