SECTION 630.060 HOURS OF OPERATION

It shall be unlawful for any peddler to engage in the business of peddling within the City between the hours of one-half (1/2) hour before sunset and 9:00 A.M. the following morning, or at any time on Sundays, except by specific appointment with an invitation from the prospective customer.

SECTION 630.130: FEE

Before any permit shall be issued under the provision of this Article, the applicant therefor shall pay a fee, based upon the duration of time he desires to engage in business in the City, as follows:

FALSE STATEMENTS MAY RESULT IN DENIAL OR WITHDRAWAL OF LICENSE AND ARE PUNISHABLE BY LAW.

A PHOTOGRAPH OF THE APPLICANT, TAKEN WITHIN SIXTY (60) DAYS IMMEDIATELY PRIOR TO THE DATE OF FILING OF THE APPLICATION, WHICH PICTURE SHALL BE TWO (2) INCHES BY TWO (2) INCHES SHOWING THE HEAD AND SHOULDERS OF THE APPLICANT IN A CLEAR AND DISTINGUISHING MANNER.

AT THE TIME OF FILING AN APPLICATION FOR A PERMIT, A FEE OF FIVE DOLLARS (\$5.00) SHALL BE PAID TO THE CITY CLERK TO COVER THE COST OF INVESTIGATING THE FACTS.

AT THE TIME OF MAKING APPLICATION FOR A PERMIT, THE APPLICANT SHALL SUBMIT TO FINGERPRINTING BY THE MARSHAL/CHIEF OF POLICE.

EVERY APPLICANT FOR A PERMIT WHO IS NOT A RESIDENT OF THE CITY OR WHO IS A RESIDENT OF THE CITY REPRESENTS A FIRM WHOSE PRINCIPAL PLACE OF BUSINESS IS LOCATED OUTSIDE THE STATE, SHALL FILE WITH THE CITY CLERK A SURETY BOND RUNNING TO THE CITY IN THE AMOUNT OF ONE THOUSAND DOLLARS (\$1,000.00), WITH SURETY ACCEPTABLE TO AND APPROVED BY THE MAYOR, CONDITIONED THAT THE APPLICANT SHALL COMPLY FULLY WITH ALL THE APPLICABLE PROVISIONS OF THIS CODE, THE ORDINANCES OF THE CITY AND STATE LAWS REGULATING AND CONCERNING THE BUSINESS OF PEDDLING AND GUARANTEEING TO ANY CITIZEN OF THE CITY THAT ALL MONEY PAID AS DOWN PAYMENT WILL BE ACCOUNTED FOR AND APPLIED ACCORDING TO THE REPRESENTATIONS OF THE PEDDLER, AND FURTHER GUARANTEEING TO ANY CITIZEN OF THE CITY DOING BUSINESS WITH SUCH PEDDLER THAT THE PROPERTY PURCHASED WILL BE DELIVERED ACCORDING TO THE REPRESENTATIONS OF SUCH PEDDLER. ACTION ON SUCH BOND MAY BE BROUGHT IN THE NAME OF THE CITY TO THE USE OR BENEFIT OF THE AGGRIEVED PERSON.
