**AN ORDINANCE FIXING THE TAX RATE FOR THE CITY OF PACIFIC,  
COUNTIES OF FRANKLIN AND ST. LOUIS, STATE OF MISSOURI, FOR  
THE YEAR 2014 AND ESTABLISHING THE EFFECTIVE DATE THEREOF.**

**BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PACIFIC,  
MISSOURI, to wit:**

**SECTION ONE:** For the support of the city government, the payment of out-standing debt, the advancement of the public interest, and the improvement of the City, taxes shall be levied on all property – real, personal, and mixed, subject to taxation for the state and county purposes within the corporate limits of the City of Pacific, Missouri in the Counties of Franklin and St. Louis for the year 2014;

**SECTION TWO:** For the use of the General Fund, the sum of forty two and seventy three tenths (.4273) per One Hundred Dollars (\$100) valuation shall be levied;

**SECTION THREE:** The 2014 Tax Rate is subject to change based on the State Auditor's approval;

**SECTION FOUR:** That all ordinances or parts of ordinances in conflict herewith are hereby repealed, insofar as they conflict;

**SECTION FIVE:** That this ordinance shall be in full force and effect on and after its passage and approval.
