AN ORDINANCE AMENDING CHAPTER 365 AND SCHEDULE IV OF CHAPTER 365 OF THE MUNICIPAL CODE OF THE CITY OF PACIFIC TO ADD NO BALLPARK PARKING AS A RESTRICTION TO SCHEDULE IV

WHEREAS, the Board of Aldermen of the City of Pacific previously instructed and signage was authorized, per existing code provisions, for the placement of parking prohibitions on Fifth and W. Meramec Streets; and

WHEREAS, the Board of Aldermen desires to permanently establish “No Ballpark Parking” prohibitions on Fifth and W. Meramec Streets specifically in the parking schedules so as to eliminate any question as to the Board’s intent as to such existing signage; and

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PACIFIC, MISSOURI, AS FOLLOWS:

Section One. Section 635.040 of the Municipal Code, entitled “Parking Prohibited During Certain Hours on Certain Streets” is hereby amended by replacing Section 635.040 with the following new Section to read as follows:

SECTION 635.040: PARKING LIMITED OR RESTRICTED

When no parking signs are erected giving notice thereof, no person shall park a vehicle within the area between the hours specified by ordinance except Sunday and public holidays or for the purpose specified by ordinance on any day within the area or upon any of the streets described by ordinance.

Section Two. Schedule IV of the Municipal Code of the City of Pacific, entitled “Parking Limited or Restricted,” is hereby amended by adding the following restriction to the Schedule IV to read as follows:

SCHEDULE IV. PARKING LIMITED OR RESTRICTED

	On both sides of South Fifth Street from W. Pacific Street to the dead end and on both sides of West Meramec Street from South Sixth Street to South Fifth Street.	No Ballpark Parking

Section Three. “Ballpark Parking” shall mean any person going to the ballpark located in City Park and generally described as the area west of the railroad tracks, north of brush creek,

east of the unnamed tributary to brush creek, and south of the midblock of Meramec Street, as more fully depicted on Exhibit A incorporated herein. Ballpark parking is authorized at City Park two (2) blocks west on Congress Street at designated parking areas.

Section Four. Except as specifically amended herein, Chapter 365, and specifically Schedule IV, of the Municipal Code of the City of Pacific shall remain in full force and effect. Nothing herein shall preclude enforcement of any other ordinance as may also apply to existing parking regulations or signage all of which shall be supplementary and independent provisions.

Section Five. This Ordinance shall be in full force and effect from and after its passage and approval by the Mayor.

This Bill was passed and approved this 4th day of December, 2012, by the Board of Aldermen of the City of Pacific, Missouri, after having been read by title or in full two (2) times prior to passage.
