AN ORDINANCE AMENDING SCHEDULE IV OF CHAPTER 365 OF THE MUNICIPAL CODE OF THE CITY OF PACIFIC TO ELIMINATE THE PARKING RESTRICTIONS ON CERTAIN AREAS OF ST. LOUIS STREET

WHEREAS, pursuant to Ordinance Nos. 1425, 1426, 2502, and 2510 the City enacted certain time-limit parking restrictions on the north and south side of St. Louis Street; and

WHEREAS, the Board of Aldermen find that time-limit parking restrictions on St. Louis Street are no longer in the best interest of the City and desire to remove such parking restrictions;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF PACIFIC, MISSOURI, AS FOLLOWS:

Section One. Ordinance Nos. 1425, 1426, 2502, and 2510 setting forth certain time-limits for parking on the north and south side of St. Louis Street are hereby repealed in their entirety. The codifier is hereby authorized and directed to delete from Schedule IV of Chapter 635 of the Municipal Code of the City of Pacific, entitled "Parking Limited or Restricted," the following restrictions:

SCHEDULE IV. PARKING LIMITED OR RESTRICTED

<i>Ord. No.</i>	<i>Location</i>	<i>Restrictions</i>
1425	On the north side of St. Louis Street between its intersection with Columbus Street west to its intersection with Third Street within the City limits.	No parking for more than two hours between 8:00 A.M. and 5:00 P.M. except on Sundays and holidays.
1426	On the south side of St. Louis Street between its intersections with Columbus Street west to its intersection with Second Street within the City limits.	No parking for more than two (2) hours between 8:00 A.M. and 5:00 P.M., except Sundays and holidays.
2502, 2510	Seven designated parking spaces on the south side of West St. Louis Street directly in front of 134 & 136 West St. Louis Street. Signage shall be placed at such seven spaces as established and designated by the Commissioner of Public Works.	No parking for more than thirty (30) minutes from 5:00 P.M. to 10:00 P.M.

Section Two. Schedule III of Chapter 635 of the Municipal Code of the City of Pacific, entitled "Parking Prohibited At Any Time," is hereby amended by deleting the two (2) hour parking limit from 8:00 A.M. to 5:00 P.M., Monday through Friday, on St. Louis Street from

Columbus Street to Fourth Street. The codifier is hereby authorized and directed to delete from Schedule III the following restriction:

SCHEDULE III. PARKING PROHIBITED AT ANY TIME

<i>Street</i>	<i>Restrictions</i>
St. Louis Street	Two hour parking 8:00 A.M. to 5:00 P.M., Monday through Friday, from Columbus Street to Fourth Street.

Section Three. Except as specifically amended herein, Chapter 365, and specifically Schedule III and IV, of the Municipal Code of the City of Pacific shall remain in full force and effect. Nothing herein shall preclude enforcement of any other ordinance as may also apply to existing parking regulations or signage all of which shall be supplementary and independent provisions.

Section Four. This Ordinance shall be in full force and effect from and after its passage and approval.

This Bill was passed and approved this 5th day of March, 2013, by the Board of Aldermen of the City of Pacific, Missouri, after having been read by title or in full two (2) times prior to passage.
