

RESOLUTION NO. 2015-16

A RESOLUTION APPROVING THE AMENDED 2014-2015 TOURISM
COMMISSION BUDGET

WHEREAS, Ordinance No. 2563 provides that the Tourism Commission shall submit to the Board of Aldermen a proposal for the expenditures of tourism funds outlining the connection of each proposed expenditure line item to the promotion of tourism; and

WHEREAS, the Tourism Commission did meet on April 7, 2014 and prepared the proposed budget for Fiscal Year 2014-2015; and again on June 2, 2014 and prepared an amended proposed budget for Fiscal Year 2014-2015;

WHEREAS, upon approval by the Board of Aldermen of the Budget as submitted by the Board, the proposed Tourism Commission shall be incorporated in the FY 2014, budget, and

WHEREAS, the amended budget includes funds for the purchase of Jensen's Point; and

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF ALDERMEN OF THE CITY OF PACIFIC, as follows:

The Board of aldermen hereby approves the Tourism Budget for Fiscal Year 2014-2015 as submitted and attached as Exhibit A hereto and incorporated herein, and the same shall be incorporated into the Fiscal Year 2014-2015 Budget for the City of Pacific.
