**PUBLIC HEARING**

**A. A Public Hearing regarding the property tax rate to be set by the City of Pacific, a political subdivision. The tax rate shall be set subject to change, based on the State Auditor's approval to produce revenues which the budget for the fiscal year beginning July 1, 2014 shows to be required from the property tax. The tax rate is determined by dividing the amount of revenue by the current assessed valuation. The result is multiplied by 100 as the tax rate will be expressed in cents per \$ 100 valuation.**

Mayor Palmore opened the Public Hearing, City Clerk Barfield read the Public Hearing into the record. Mayor Palmore asked for comments from the public. BJ Lawrence asked if the tax rate was going up. Mayor Palmore stated he would refer this to the City Clerk as he did not understand the process. City Clerk Barfield stated this is a revenue neutral formula, and was based off of the valuations received from the county. City Attorney Schroeder stated this is based on the total valuation, if your

individual piece of properties valuation has increased or decreased you will see that on your bill. There being no further comments, Mayor Palmore closed the public hearing.



**ADJOURNMENT**


