### A. General Licenses

#### 1. Package Liquor Sales

- B. *Duration:* Of the license fee to be paid for any such license (other than temporary permit), the applicant shall pay as many twelfths (12ths) as there are months remaining from the date of the license to the next succeeding July first (1<sup>st</sup>). For purposes of this subsection, part of a month shall count as a whole month.
