VIOLATIONS BUREAU SCHEDULE OF OFFENSE AND FINES
EFFECTIVE JANUARY 1, 2020

Pursuant to the Missouri Statute 479.050, Rule 37.495 of the Supreme Court Rules of the State of Missouri and Section 130.100 of the Code of the City of Pacific, undersigned Municipal Judge of the City of Pacific hereby orders that the following designated offenses shall be payable to the City of Pacific Violations Bureau. In such cases, no court appearance is necessary. Any violation resulting in personal injury or property damage may not be paid through the Violations Bureau. In accordance with Missouri statutes and city ordinances, the total amount of court costs charged shall be \$25.50. This includes: Court Costs of \$12.00, Crime Victim's Compensation Fee of \$7.50, Law Enforcement and Peace Officer Fund Fees of \$3.00, Educational Training Fund of \$1.00, and \$2.00 Inmate Prisoner Detainee Security Fund.

If you do not want to appear in court, you may satisfy the offense listed above by: 1. Signing the back of your ticket and 2. Mail the ticket with a Cashier's Check or Money Order for the correct amount payable to "Pacific Municipal Court", 300 Hoven Drive, Pacific, Missouri 63069; or 3) Pay in person at the above address between the hours of 8:30 am and 4:30 pm (Sat., Sun. and Holidays excluded); or 4) Online at "<https://www.ipaycourt.com/Pacific>".
